Abstract

This research focused on analyzing regarding universal health coverage and it's implementation in Indonesia during pandemic COVID-19. Universal Health Coverage has been displaced by the COVID-19 pandemic while disparities in outcomes have exposed stark gaps in quality, access, equity, and financial risk protection regarding health services in Indonesia. This research would answer the following questions: (1). What is obligation of the government of Indonesia to respect, protect and fulfill regarding universal health coverage during pandemic COVID-19; (2). How political-legal mechanism to comprehensive implementation of universal health coverages in Indonesia.

This research used socio-legal studies to identify correlation between universal health coverages and fulfillment of health rights for Indonesian peoples. In Indonesia, with system of national health assurances (Jaminan Kesehatan Nasional-JKN) must be implemented and relevance with Universal Health Coverage efforts have yet to carry through to provision of good quality, accessible and equitable service delivery could potentially benefit from concurrent Networks of Care implementation. Documentation of Networks of Care in the context of Universal Health Coverage should be prioritized to understand how Networks of Care can be used to help realize the goals of Universal Health Coverage to respect, protect, and fulfillment of health rights for Indonesia peoples.
